Parade Rules

- Floats, vehicles / trailers/ golf carts, ATV, etc. must be decorated with a Mardi Gras décor theme
- Applicant agrees to abide by MGSET parade rules and regulations
- Proof of proper vehicle insurance in accordance with state law, \$ 300,000 minimum coverage required
- Sufficient traditional Mardi Gras throws required per rider for the 2-mile parade - **No candy permitted**
- Float walkers required for all floats – minimum 6, must be 14 yrs of age or older and able to handle the crowd
- Neon safety vest required for float walkers
- Maximum clearance for all entries is 16 feet
- Tailgating in the Red Lot at Doggett Ford Park is encouraged before parades, great time to visit and enjoy friends

IS LEFT CLEAN AND TRASH FREE**

- ✓ **Two (2) PORTABLE (2A10BC TYPE) FIRE EXTINGUISHER
FOR FLOAT and TOW VEHICLE**
- ✓ **IF THE FLOAT STOPS - STOP THROWING**
- ✓ **FLOAT GUARDS (minimum of 6 required, 14 years or older) Floats
will not roll without float guards or neon safety vest.**
- ✓ **GENERATOR IN TOW VEHICLE – NO PASSENGERS IN BED
OF TRUCK**
- ✓ **EXTRA GASOLINE FOR GENERATORS**
- ✓ **TOILET PAPER AND PAPER TOWELS, BATHROOM AND CLEANING
SUPPLIES, BROOM AND TRASH BAGS**
- ✓ **SOUND SYSTEM FOR FLOAT & MUSIC**
- ✓ **NO GLASS CONTAINERS- PAPER OR PLASTIC**
- ✓ **STAGING AREA IS TO BE CLEANED AND ALL TRASH
PLACED IN DUMPSTER**
